*The Mujahedin-e Khalq (MEK) is Iran's principal opposition movement. According to senior U.S. government officials, in a goodwill gesture to the Iranian regime, the Department of State designated the group as a Foreign Terrorist Organization (FTO) in 1997. The United Kingdom and the European Union removed the MEK from their respective watch lists in 2008 and 2009. A Federal Appeals Court in Washington, DC, ordered the Secretary of State to review the MEK's designation, which it found to be in violation of the group's due process rights. Since 2010, more than 130 Members of U.S. House of Representative have cosponsored resolutions, calling for the delisting of the MEK. Camp Ashraf, Iraq, is home to 3,400 members of the MEK, including 1,000 women.*
